Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with auditing standards generally accepted in the United States of America and Government Auditing Standards will always detect a material misstatement when it exists. Misstatements, including omissions, can arise from fraud or error and are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment of a reasonable user made based on the financial statements. The objective also includes reporting on:

Our responsibility as auditors is limited to the period covered by our audit and does not extend to any later periods for which we are not engaged as auditors.

Texas Ethics Commission Form 1295

In accordance with Election Code, Chapter 32, Subchapter E. Compensation Section 32.091 (c) states "an election judge or clerk is entitled to compensation for services rendered at a precinct polling place at an hourly rate not to exceed the amount fixed by the appropriate authority, which amount must be at least the federal minimum hourly wage. A judge or clerk may be compensated at that rate for services rendered under Section 62.014(c)."

Fort Stockton ISD has agreed to contract services through Pecos County for Early Voting and Election Day. Pecos County will pay election workers in accordance with the set compensation. Fort Stockton ISD will reimburse Pecos County according to the Contract for Election Services.

Section 32.092 states: "... the election judge or clerk who delivers the precinct/ward election records, keys to ballot boxes, or other election equipment, and unused election supplies after an election is entitled to compensation for that service in an amount not to exceed \$25.00."

Fort Stockton ISD has agreed to contract services through Pecos County for Early Voting and Election Day. Pecos County will pay election workers in accordance with the set compensation. Fort Stockton ISD will reimburse Pecos County according to the Contract for Election Services.
